Re-calculating Our Paths, Reaffirming Our Values



HEALTH CARE REFORM

California's Affordable Care Act Implementation - Local implications, Federal Initiatives, future of the "carve-outs" (Specialty Mental Health waiver), Integrated Health Home models that include substance abuse treatment.

CLINICAL & COMMUNITY BASED PROGRAMMING

Schools and Education - School-to-Prison Pipeline, AB 3632 replacement regulations, exclusion-disparities in our public $schools, \, hostile \, learning \, environment \, (bullying), \, enhancing \, school \,$ environment, post-3632, supporting positive school leadership, "search and serve" child finding.

Public Safety and Child Welfare Partnerships - Advocacy through Child Welfare & Child Protective Services Probation, TAY & AB 12 Child Welfare Council, impacts to courts & social services, social services' systems of care.

FAMILY EMPOWERMENT, RESOURCES, TECHNOLOGY

Access by parents to technology, parent skills to monitor their child's web/ tech use (Lucille Packard showcase), parents' transition after child turns 18, parenting a child with special needs, empowerment of caregivers, info on IEP services, eligibility nuts and bolts guidance, "How To" workshops for families and youth, link with stigma campaigns, patient/child centered.
