Federal Report: 57 Recommendations for Combating Opioid Crisis

The President's Commission on Combating Drug Addiction and the Opioid Crisis, established in March 2017, released its final report on November 1, 2017. The report outlines a series of recommendations to the federal government for opioid prevention, treatment, overdose reversal, recovery, and research and development.

New Research: Cannabis and Alcohol Negatively Impact Lifetime Achievement in Young Adults

Research presented in November at the American Public Health Association's 2017 Annual Meeting and Expo examined the effect of marijuana use and dependence on life achievement in young adults. The study found that young adults who are dependent on marijuana and alcohol were less likely to achieve adult life goals, defined by the study as educational achievement, full-time employment, marriage, and social economic potential.
